Executive Order No. 4 aims to prevent State agencies from proposing any future new unfunded mandates on local governments. Agencies are required to provide fiscal analysis and input from the affected local government units, businesses and stakeholders.

While this executive order is prospective, the League's Mandate Relief Committee, co-chaired by Hamilton Township (Mercer) Mayor John Bencivengo and Mayor Anthony Persichilli of Pennington, has been working to identify targeted mandates for roll back.

Your local winning entry must be submitted to the League office by April 1, so we can announce the three statewide winners by May 7.

For the 11th consecutive year, over two hundred mayors offered their views on several major policy areas in response to the League's Annual Legislative Priority Survey. Their responses to specific issues provide a source of direction and will assist League Executive Board and staff during what could prove to be a critical year for municipalities and property taxes. Property taxes, state mandates, and the costs that affect taxes are foremost on Mayors' minds as they begin to prepare for the New Year. 92% of the mayor's responding said they would support reforms that would fund **school districts' budgets** with revenue from source other than property taxes. 83% stated they support a **citizens' convention** to address both property taxes and government spending.
