

COOPERATIVE AGREEMENT

THIS AGREEMENT dated this *29th* day of 2005, *November*

BETWEEN:

TOWNSHIP OF WEST MILFORD
A Municipal Corporation of the State of
New Jersey with offices located at
1480 Union Valley Road
West Milford, NJ 07480

Hereinafter "Township"

AND:

BOROUGH OF RINGWOOD
A Municipal Corporation of the State of
New Jersey with offices located at
60 Margaret King Avenue
Ringwood, NJ 07456

Hereinafter "Borough"

WHEREAS, the Township and Borough have been awarded an MP3 Grant by the Highlands Council; and

WHEREAS, pursuant to Resolutions by the Township and the Borough, they have agreed to share such funding resources in order to maximize the grant and various planning resources and information available to the respective communities; and

WHEREAS, pursuant to N.J.S.A. 40:8A-1, et al, known as the Interlocal Services Act, the Township and the Borough desire to work together in utilizing such MP3 Grant funding.

NOW, THEREFORE, in accordance with the terms of this Agreement, the parties agree to the following:

1. Each community will be represented by eight (8) members appointed by the respective governing authority to form a joint committee;
2. The members shall meet and pool their respective resources in order to fully maximize grant funding available from the Highlands Council and in accordance with the MP3 Grant;


3. Wherever possible, the respective municipalities will utilize such grant monies, for such services from the respective communities', planning, engineering, other municipal departments;
4. There will be minutes taken for each meeting of the committee and copies of same will be provided to the respective governing bodies;
5. The purpose of the Committee is to comply with the New Jersey Highlands Council MP3 Grant and the requirements contained within the Grant.
6. By signing below, the parties hereby bind their respective entities as to the terms of this Agreement.




