**WHEREAS, N.J.S.A. 40:8A-1** provides that any local unit of the State may enter into contracts with other units for the purposes of joint services within their jurisdictions; and

**WHEREAS,** the parties hereto are desirous of entering into an agreement with Manchester Township has lead agency to supplement the costs of the removal of hazardous wastes at a law enforcement firearms range located within Manchester Township.

**NOW, THEREFORE,** each municipality in consideration for the mutual promises and agreements hereinafter set forth, the parties hereto agree as follows:

1. Manchester Township shall continue to provide the service of permitting the municipalities that are party to this agreement the use of the firearms range located within Manchester Township.

2. The municipalities who are parties to this agreement acknowledge that it is necessary to remove hazardous wastes at the Township firearms range.
  
3. The parties acknowledge that the estimated cost for the transportation and disposal of this hazardous waste is \$33,832 and that the County will appropriate \$16,916 for the project and the total municipal share is \$16,916.
  
4. Each municipality who is party to this agreement agrees to contribute to the lead agency in the sum of \$2,500 for financial assistance for the removal of hazardous wastes from the firearms range located within Manchester Township.
  
5. Either party to this agreement may cancel this contract upon thirty (30) days written notice.
