

**CONTRACT FOR LOCAL PUBLIC HEALTH SERVICES WITH
POMPTON LAKES**

This Contract, made and entered into this first day of January in the year Two Thousand and Five, by and between THE TOWNSHIP OF WEST MILFORD, IN THE COUNTY OF PASSAIC, a body politic, with offices in the Town Hall at 1480 Union Valley Road, West Milford, New Jersey, hereinafter referred to as the Provider, AND THE BOARD OF HEALTH OF THE BOROUGH OF POMPTON LAKES, IN THE COUNTY OF PASSAIC, with offices in the Borough Hall, 25 Lenox Avenue, Pompton Lakes, New Jersey, hereinafter referred to as the Recipient.

WHEREAS, the Recipient desires to contract with the Provider for furnishing to the Recipient health services of a technical and professional nature as hereinafter set forth; NOW, THEREFORE, it is understood and the parties do hereto agree as follows:

1. The Provider shall provide the services of a properly licensed Health Officer to provide general assistance in carrying out, within the territorial jurisdiction of the Recipient, the public health activities as required by "Recognized Public Health Activities and Minimum Standards of Performance for Local Health Departments in New Jersey".
2. The Recipient designates the Health Officer, employed by the Provider, subject to the authority of the Local Board of Health of the Borough of Pompton Lakes, and in accordance with the New Jersey Statutes 26:3-19, as its general agent for enforcement of its sanitary ordinances and the sanitary laws of the State during the term of this Contract.
3. The Health Officer of the Provider, so assigned to the Recipient, shall have all the power and authority, as if directly employed by the Recipient, when rendering services assigned to them by the Recipient.
4. The Health Officer, when acting for Recipient, shall assist personnel of the Recipient in making of investigations and shall inform the Recipient regarding any and all violations of Statutes and Ordinances related to public health of Pompton Lakes, and to assist its attorney in obtaining compliance with the law.
5. It is understood and agreed that the Council of the Provider and the Board of Health of the Recipient shall have a joint meeting of designated representatives at least twice a year.
6. (a) The Health Officer provided through this Contract shall provide assistance to the Health Inspectors and Sanitarians of the Recipient to obtain compliance with State and local health laws.
(b) His/Her duties will include: emergencies, consultations, inspections as needed and other duties as assigned, and attendance at meetings upon request by the President of the Board of Health.
(c) The Health Officer of the Provider shall direct and supervise all public health activities and employees of the Recipient.

This contract has been funded by the Board of Health of the Borough of Pompton Lakes through the Temporary Budget of the Borough of Pompton Lakes. Continuation of this Contract past March 31, 2006 is subject to appropriation of sufficient funds in the Final Budget adopted by the Borough of Pompton Lakes, for the year 2006.

WHEREAS, a contract has been submitted for such joint use wherein the Township of West Milford is the provider of the services from the Health Officer, and Pompton Lakes Borough is the Recipient of those services.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of West Milford, that the proposed contract (copy attached) for the Township of West Milford and Pompton Lakes Borough be and the same is approved for the period January 1, 2006, through December 31, 2006, the Administrator and Township Health Officer be and they are hereby authorized and directed to sign and/or attest to said contract for and in behalf of the Township of West Milford.
