

**ADDENDUM TO AGREEMENT  
FOR INTER-MUNICIPAL COURT  
FOR THE MUNICIPALITIES OF FRANKFORD TOWNSHIP,  
LAFAYETTE TOWNSHIP, THE BOROUGH OF BRANCHVILLE,  
AND SANDYSTON TOWNSHIP**

**WHEREAS**, by Agreement dated November 19, 1996, the Township of Frankford, Township of Lafayette, Borough of Branchville and Township of Sandyston, agreed to maintain a joint municipal court pursuant to N.J.S.A. 2B:12-1; and

**WHEREAS**, the aforesaid municipalities wish to continue to be bound by the terms and conditions of the aforesaid Agreement, subject only to the amendments contained in this Addendum.

**NOW, THEREFORE**, the Townships of Lafayette, Sandyston and Frankford, and the Borough of Branchville, agree as follows:


1. For a period of three (3) years, commencing on January 1, 1998, all four (4) municipalities agree to pay rent to the Township of Frankford at the rate of Fifteen (\$15.00) Dollars per square foot, for those portions of the Frankford Township Municipal Building that are used by Court personnel or for the administration of the Court. With respect to the Mechanical Room located within the Frankford Township Municipal Building, the municipalities agree to pay rent to the Township of Frankford at the rate of Seven (\$7.00) Dollars per square foot. With respect to the chairs located in the Courtroom, all four (4) municipalities agree to share equally in paying one-half (1/2) of the total cost incurred by Frankford in the purchasing the chairs. In addition to the above charges, all four (4) municipalities agree to share equally in the payment to the Township of Frankford of the sum of One Hundred Twenty-Five (\$125.00) Dollars per night, for each night that a court session is scheduled at the Frankford Township Municipal Building. The four (4) municipalities will also share equally the cost of other furniture used in the court room, hall, Court Administrator's office and prosecutors/public defender's office. The total cost is \$13,405.41 or \$3,351.35 for each municipality.

2. In all other respects, the terms and conditions of the aforesaid Agreement, dated November 9, 1996, shall remain in full force and effect


3. This Addendum to Agreement will become effective only after ordinances authorizing execution of this Addendum have been passed by the governing bodies of each of the four (4) municipalities. Upon passage of the ordinances, this Addendum to Agreement will be filed with the Administrator Director of Courts.
