

## RESOLUTION

November 17, 2004

**WHEREAS**, it is the aim of the County to reduce the amount of solid waste generated in Ocean County through recycling programs in order to decrease dependence on landfills while providing reliable, environmentally sound and economical method of waste management; and

**WHEREAS**, the Board of Chosen Freeholders has adopted a Recycling Plan for the Ocean County Solid Waste Management District pursuant to the provisions of the Statewide Mandatory Source Separation and Recycling Act, N.J.S.A. 13:1E-99.11 et seq., and the Solid Waste Management Act, N.J.S.A. 13:1E-1 et seq.; and said Plan has received the approval of the Commissioner of the New Jersey Department of Environmental Protection as requires by law; and

**WHEREAS**, the County currently owns and operates two (2) County Recycling Centers for the receipt, processing and marketing of source separated commingled recyclable materials located at Recovery Road, Stafford Township, New Jersey, New Hampshire Avenue, Lakewood Township, New Jersey, respectively known as the Southern and Northern Recycling Centers; and

**WHEREAS**, the County desires to provide assistance to all municipalities located within the County in meeting their recycling goals as established by the Mandatory Source Separation and Recycling Act and the Ocean County Recycling Plan; and

**WHEREAS**, the governing bodies of the following municipalities wish to enter into an Agreement with the County for the use of the County's Recycling Centers and participation in the Recycling Revenue Sharing Program:
