


AMENDMENT TO THE INTERLOCAL AGREEMENT

This Amendment to the original Interlocal Agreement is entered into by and between the Township of Hazlet, located at 1776 Union Avenue, Hazlet, NJ, hereinafter referred to as the "Township", the Hazlet Policemen's Benevolent Association Local 189, located at 255 Middle Road, Hazlet, NJ, hereinafter referred to as the "PBA", the Hazlet Township Chief of Police, also 255 Middle Road, Hazlet, NJ, hereinafter referred to as "Chief," and the Hazlet Township Board of Education, located at 421 Middle Road, Hazlet, NJ, hereinafter referred to as the "Board".

This Amendment shall extend the term of the original Interlocal Agreement, which was in force from July 1, 2002 through June 30, 2005. This extension shall be for the period from July 1, 2005 through June 30, 2009. All terms and conditions as enumerated in the original Interlocal Agreement shall remain in force.



INTERLOCAL AGREEMENT

This Interlocal Agreement is entered into by and between the Township of Hazlet, located at 319 Middle Road, Hazlet, NJ, hereinafter referred to as the "Township", the Hazlet Policemen's Benevolent Association Local 189, located at 255 Middle Road, Hazlet, NJ, hereinafter referred to as the "PBA", the Hazlet Township Chief of Police, also 255 Middle Road, Hazlet, NJ, hereinafter referred to as "Chief," and the Hazlet Township Board of Education, located at 421 Middle Road, Hazlet, NJ, hereinafter referred to as the "Board".

1. PROVISIONS

This contract shall govern the contractual arrangement for police supervision for all school activities, both sports related and curriculum/activity related, wherein such events shall require police officer(s) for security purposes as agreed to by all three parties.

2. DURATION OF CONTRACT

This contract shall be in force from July 1, 2002 through June 30, 2005.

3. FEES

The Board agrees to pay the rate of forty dollars (\$40) per hour per police officer for each event that requires a minimum of one (1) officer for security purposes for the period from July 1, 2002 through June 30, 2003. The Board agrees to increase the rate annually by four percent (4%). Such rate adjustment shall be effective on July 1 of each subsequent year of this contract. This rate shall be inclusive of all other fees that may be charged to other parties that contract with the Township of Hazlet for police coverage, with the exception of social security and workman's compensation fees as determined by the Township.

4. MINIMUM LENGTH OF EVENT

Each police officer shall be utilized for no less than three (3) hours for any one event, unless the PBA agrees to waive this requirement at its discretion.

5. NUMBER OF POLICE OFFICERS REQUIRED FOR EVENTS

During the period from July 1, 2002 through June 30, 2003, the minimum number of police officers for event coverage shall be estimated at 82 per the schedule developed by the Hazlet Township Board of Education's Athletic Director and reviewed and agreed to by the Chief of the Hazlet Township Police Department and shall be attached hereto as Appendix A. Any police officer assigned to an event shall have the discretion of requesting additional police support where he determines that the situation warrants it. Such discretion shall also be granted to the Board's administrator in charge of the event, with the cooperation of the PBA.

The minimum number of police officers required for subsequent years of this contract shall be agreed to by all parties to this contract prior to July 1 of each year.


